Re: Provision of electronic files for the title/s detailed above.

The electronic files (hereinafter termed the Original Files) for each content item above (each hereinafter termed the Work) are being provided on the understanding that each User named above, who has a physical or mental impairment which prevents that person from enjoying works to substantially the same degree as a person who does not have that impairment (which is not a visual impairment that can be improved, e.g. by use of corrective lenses, to a normally acceptable reading level), will be able to enjoy the Work to the aforementioned degree if it is in a suitable alternative electronic format (such accessible copy hereinafter termed the Alternative Format).

The Alternative Format must have the sole purpose of enabling the User to access the Work, despite the above impairment, including as feasibly and comfortably as a person who does not have such an impairment, for the User's personal use only.

Permission to use the Work in the form of the Original Files and the Alternative Format is therefore subject to the following provisions:

1. Subject to 2. and 3. below the User (or a person acting on the User's behalf) **MAY**:
 - Store the Original Files on the User's (or such person's) personal computer or other electronic device, for the sole purpose of converting the Original Files into an Alternative Format; and
 - Store the Alternative Format and make the Alternative Format accessible to the User on the User's (or such person's) computer or electronic device, for the User's personal use only.
2. The User (and any person acting on the User's behalf) **MAY NOT**:
 - Copy, print, make available (via any method, including without limitation on the Internet or any online means) or otherwise use the Original Files or the Alternative Format (or any part thereof), or transfer them to any other person, except as necessary for the sole purpose of enabling the User to access the Work in the Alternative Format for the User's personal use only as set out above; nor
 - Use either the Original Files or the Alternative Format for any commercial purpose(s).
3. In addition, the following conditions apply:
 - The Alternative Format may include facilities for navigating around that version of the Work but must not include any other changes to the Work which are unnecessary to overcome the problems suffered by the User in accessing the Work for which the Alternative Format is intended in accordance with this Agreement, without the prior written approval of Taylor & Francis (such approval to be given, conditioned or withheld at Taylor & Francis' absolute discretion); and
 - Subject to the previous bullet point, the Alternative Format must respect the integrity of the Work; and
 - An acknowledgement must be made to the material prominently on the introductory screen of the Alternative Format as follows: "[author/editor], [title], [year of publication], [publisher - as it appears on our copyright page] reproduced with permission of Taylor & Francis"; and
 - The Original Files must be permanently deleted once the Alternative Format has been created but the Alternative Format may be retained by the User (or any person acting on the User's behalf) in perpetuity; and
 - This Agreement is subject to the purchase of, or other lawful access to, an edition of the Work in any format (print, electronic or otherwise) and Taylor & Francis reserves the right to request that the User (or a person acting on the User's behalf) delivers applicable proof of purchase, or other lawful access, in writing to Taylor & Francis.
